British Columbia municipal police agencies are authorized under s.26(c) of the Freedom of Information and Protection of Privacy Act to collect personal information because the information relates directly to and is necessary for the activity of determining suitability for security clearance in the policing environment. West Vancouver Police Department will collect information for the purpose of assessing the integrity, honesty, and character of applicants to determine suitability for security clearance. IMPORTANT: PRIOR SERIOUS CRIMINAL OFFENCES AND SERIOUS RISK TO THE SAFETY OF OTHERS

The information you provide during the Recruiting Process is collected by the West Vancouver Police Department for the purpose of an employment application. However, if an applicant admits to having committed a serious and undetected criminal offence or is deemed to pose a serious risk to the safety of others, the West Vancouver Police Department may use or disclose specific information for a law enforcement or public safety purpose. While cases of such use and disclosure outside of the recruiting process are rare and exceptional, the West Vancouver Police Department **strongly discourages** an applicant from completing this form if you believe this notice applies to you.

ACCESS, RETENTION AND DISCLOSURE OF YOUR INFORMATION

The information that is gathered in this security clearance process is stored and protected under the terms of s.30 of the Freedom of Information and Protection of Privacy Act, which requires a public body to protect personal information in its custody or under its control by making reasonable security arrangements against such risks as unauthorized access, collection, use, disclosure or disposal. Your information will be stored securely within Human Resources, and access to records entered onto human resources databases will be restricted to those involved in the recruiting process. If you are not offered employment with West Vancouver Police Department, your records will be destroyed after 5 years for Police applications, and 1 year for Civilian applications.
